(4) Saves from repeal certain local laws and ordinances and designates certain matters not affected by repeal. (5) Retains the meaning and intent of previously adopted legislation.

ously adopted legislation. (6) Provides for the filing of a copy of the Code in the Town Clerk's office. (7) Provides for certain changes in or additions to the Code. (8) Prescribes the manner in which amendments and new legislation are to be incorporated into the Code. (9) Requires that Code books be kept up-to-date. (10) Provides for the sale of Code books by the town and the supplementation thereof. (11) Prohibits tampering with Code books, with offenses punishable by a fine of not more than \$250 or by imprisonment for not more than 15 days, or both. (12) Establishes severability provisions with respect to the Code generally. (13) Provides that the local law will be included in the Code as Chapter 1, Article I.
